Dear Mr Alfred N Gichu,

In response to your letter dated 9 July 2012 and the letter dated 26 July 2012 requesting targeted support from the UN-REDD Programme, and based on Kenya's government consultations with Food and Agriculture Organization of the United Nations (FAO), the United Nations Development Programme (UNDP) and United Nations Environment Programme (UNEP), I am pleased to inform you that your request was approved as follows:

The UN-REDD Programme will provide support with a total amount of US\$ 180 000 with the following breakdown of the support by the participating agencies;

- 1- FAO will provide support to a comprehensive gap analysis of the forest-related legal framework relevant to REDD+ and provide assistance for drafting REDD+ provisions to clarify and regulate major REDD+ legal issues prioritized by the Government, focusing on land and carbon tenure issues. The initial amount is US\$ 40 000 (phase I of the work plan).
- 2- UNDP will provide support to the work related to anti-corruption, carbon rights and benefit-sharing with an amount of US\$ 80 000.
- 3- UNEP will provide support to a workshop and high-level panel on green economy investments in forests with an amount of US\$ 60 000.
