2) Facilitate a series of cross-sectoral dialogue on different thematic issues related to SFM and REDD+ that cut across sectors (that contributes to the delivery of Roadmap Output 2.c.1 and 2.c.2).	80,000
3) Support for the implementation and coordination of the targeted activities	20,000

## Request for 2014 Targeted Support

Country: Mongolia

Prepared by: Ministry of Environment and Green Development, Mongolia

### I. SUMMARY OF REQUEST

#### Main objective

The objective of this Targeted Support is to initiate the implementation of Mongolia's National REDD+ Readiness Roadmap, while the funding request for a full-size UN-REDD National Programme is currently being prepared for submission to the UN-REDD Policy Board in June. Given that Mongolia's UN-REDD National Programme will not be operational until early 2015, this Targeted Support is therefore to maintain the current momentum towards the REDD+ readiness in the country, and to ensure the on-going efforts of the relevant national institutions and development partners are well coordinated to contribute to developing capacities for REDD+.

The proposed Targeted Support will also build on the outcomes of the previous support through UNDP in identifying options for mainstreaming financing for sustainable forest management into sectoral budgets. The Targeted support will help enable continued capacity development for strategic policy formulation and implementation and ensure national ownership of the REDD+ Roadmap process in Mongolia.

#### Main results expected

Two specific activities under the Roadmap have been identified as priorities, as their early start would benefit other activities in the Roadmap by building necessary bases for initiating them. The two activities to be implemented through this second-phase of the Targeted Support are described below.

##### 1. Roadmap Activity 2a.1

*Identify and analyse the drivers of deforestation and forest degradation (D&D). This will include a review and further in-depth analysis of the provisional list of drivers listed in Component 2 of the Roadmap.*

Description: Several studies on drivers of D&D already exist, but an understanding of underlying causes and their complex relations from the socio-political and -economic, biophysical and technological perspectives is still lacking in order to identify specific policies and measures to effectively address the drivers of D&D. The Targeted Support will therefore enable review and consolidation of existing studies on drivers of D&D and a political economy analysis of drivers of D&D to identify underlying causes and their relations from policy and practice levels. This will provide the necessary base for identifying policy, regulatory and incentive options for addressing those causes.

Output: This Targeted Support will directly contribute to the delivery of Roadmap Output 2a through identification of options for addressing drivers of deforestation and forest degradation.

Requested Budget: US\$ 120,000

##### 2. Roadmap Activity 2c.1 -2

- Mobilize stakeholders and design the capacity assessment;



	<ul style="list-style-type: none"> <li>• <i>Conduct the Capacity Needs Assessment ( and implement recommendations)</i></li> </ul> <p><u>Description:</u> The previous Targeted Support on mainstreaming financing for sustainable forest management (SFM) developed an action plan to increase cross-sectoral efforts in SFM. One of the key recommendations points to the importance of recognizing divergent sectoral interests in forest resources and seeking common interests that might exist through SFM as a basis for cross-sectoral capacity development. Through the Targeted Support, a series of cross-sectoral dialogues will be facilitated on different thematic issues related to SFM and REDD+ that cut across various sectoral interests (e.g., economic opportunities, links to green economy, fiscal decentralization, corruption, REDD+ finance management, nature conservation and ecosystems, social justice, forest fires and pest control, politics of land use and forest inventory, etc.) to help find common ground between sectors through SFM and REDD+.</p> <p><u>Output:</u> This Targeted Support will directly contribute to the delivery of Roadmap Output 2c.1 and 2 through identification and implementation of actions to develop cross-sectoral coordination and collaboration for REDD+.</p> <p><u>Requested Budget:</u> <b>US\$ 80,000</b></p> <p>3. <b>Additional amount of US\$ 20,000 is also requested for the implementation and coordination of the Targeted Support activities.</b> A national coordinator for the Targeted Support will be recruited to help implement the above described activities in coordination with other Targeted Support activities provided by FAO and UNEP and support the preparation and initiation of Mongolia's UN-REDD a National Programme. Additional \$20,000 will be requested through a separate TS proposal to UNEP to recruit support staff to assist the national coordinator and to cover running costs associated with the implementation and coordination of the TS activities.</p>

Given that Mongolia's full-size UN-REDD National Programme would not be operational until early 2015, this Targeted Support is therefore to maintain the current momentum towards REDD+ readiness in the country, and to ensure the on-going efforts of the relevant national institutions and development partners are well coordinated to contribute to developing capacities for REDD+.

Two activities under the Roadmap have been identified as priorities, as their early start would benefit other activities in the Roadmap by building necessary bases for initiating them. The two activities to be implemented through this second-phase of the Targeted Support are listed in table section III.

In addition, to ensure effective implementation and coordination of the proposed Targeted Support activities with the relevant on-going efforts of the national institutions and development partners, an additional amount is added to establish a small implementation and coordination unit dedicated to manage this Targeted Support in Mongolia.


